- PROMOTE students to participate in the activities hosted by ECH such as competitions, schemes and events which will benefit the student entrepreneurs.
- EXCHANGE of incubatees/ students/ entrepreneurs/ faculty and provide required mentorship and equipment facilities as required by the start-ups with nominal charges (annexure attached).
- GUIDANCE on intellectual property right strategy to be followed by the Company or Start-Up, in line with the larger strategy of the business model, pitch deck and funding proposals based on the start-up requirements on mutually agreeable terms.
- PROVIDE IPR facility to both the parties students and receive acknowledge for the same.
- PROVIDE infrastructure facility such as auditorium and networking rooms for holding conference, meetings and entrepreneurship awareness camps by the party.
