Memorandum of Understanding

This MEMORANDUM OF UNDERSTANDING (hereinafter "MoU") was made at Jaipur on 2nd July, 2022 by and between:

S . S Jain Subodh Girls P.G. College, Sanganer, Jaipur, an institution committed to excellence and overall development of girls with a focus on entrepreneurial activities and community service, situated near Sanganer airport, Jaipur 302029, (Rajasthan)

And

Empowering Women Organisation, an apex chamber of Trade & Industry of the state of Rajasthan. It is the premier platform to encourage business and trade in Rajasthan active in areas of educating, mentoring, networking, developing and investing in innovative startups, and having its registered office at Ganpati Enclave, A-7, Second Floor, Ajmer Road, Civil Lines, Jaipur - 302006, hereinafter referred to as "EWO".

S . S Jain Subodh Girls P.G. College and **EWO** desire to work together towards empowering the disempowered or powerless and change their circumstances and begin to have control over their lives in order to result in a change in the balance of power, in the living conditions, and the relationships and also building a robust trade and industry ecosystem in Jaipur and undertake joint events and programs leading to strengthening, building and the growth of the target group. This would be done through undertaking activities under various programs planned jointly and in mutual agreement and acceptance.

A) Objectives:

To advance the aforesaid commitment, **Subodh** and **EWO** will work together towards achieving the following objectives on a non-exclusive basis:

1. to provide a framework for the participants to advance equality, empowerment and the promotion of the human rights of girls and women as part of their bilateral relationships.
2. access to mentoring support
3. access to angel investors and funding support to startups.

B) Roles and Responsibilities

Key roles and responsibilities of Subodh :

1. Conduct different activities for women entrepreneurs and students.
2. Make the calendar for the programs and share the same with EWO for their consent
3. Assess the mentoring needs of the participating startups
4. Coordinate with EWO representatives to schedule mentorship/feedback sessions atleast 15 days prior to the event / program
5. Provide a venue for events.
6. Conduct activities if required for different events conducted jointly by SUBODH and EWO

6. Send volunteers if required for different events conducted jointly by SUBODH and EWO

Key roles and responsibilities of EWO:

1. Provide relevant industry and expert connections to motivate startups, based on their requirements and expert's availability, within EWO industry/mentorship network.
2. Source mentors are required well in advance as per the schedule of activities and sessions informed by SUBODH and then confirm their availability at the earliest.
3. EWO Women Wing will help in the outreach of the possible joint programs through its channels like email, social media handles.
4. Sensitization of startups through speakers in various events.

C. Tenure

This MoU shall commence on the date of execution and shall continue till 30 th April ,2023 after which it can be further extended in writing by mutual consent.

C) Representatives

In all dealings between the parties, SUBODH shall be represented by **The Principal , Dr Rita Jain**

while

The EWO will be represented by **Mrs. Alka Agrawal ,President ,EWO** .The representative shall assign duties to relevant team members, as and when deemed necessary.


